

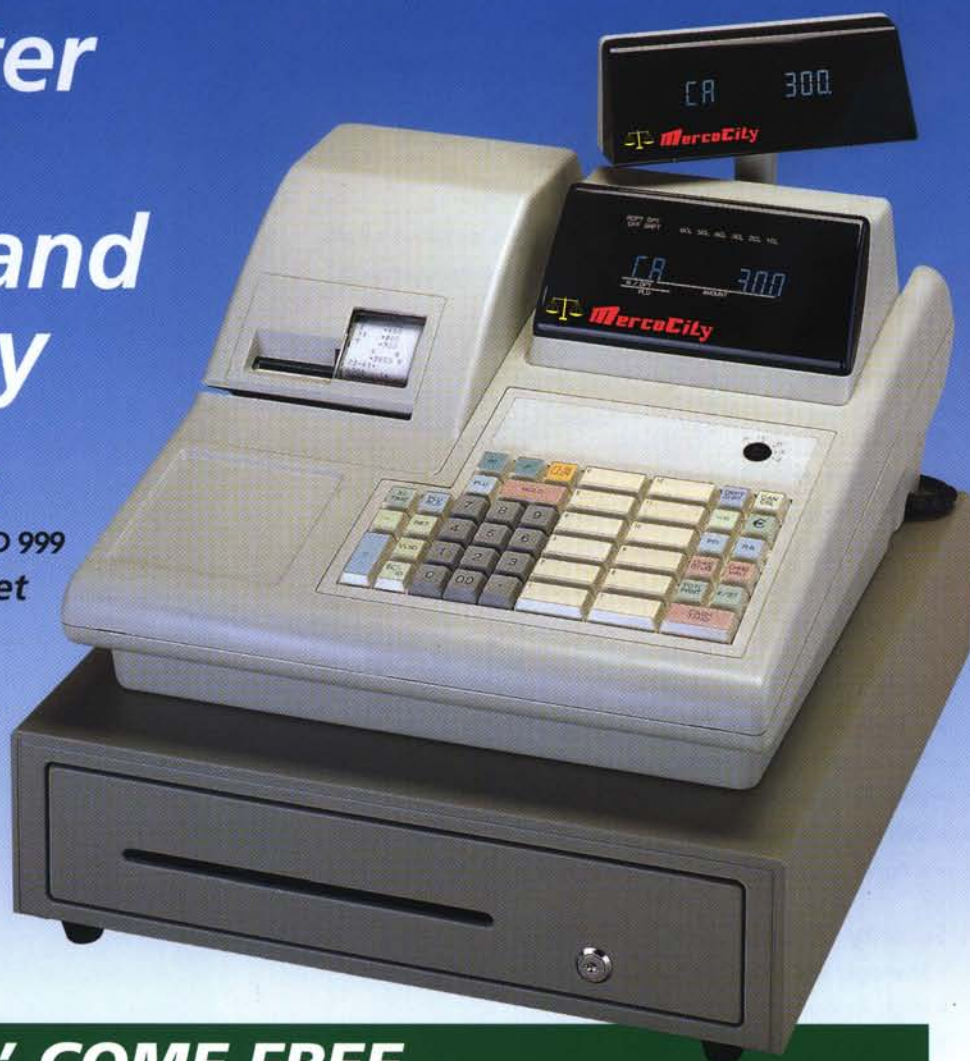

Works to improve the way you do business

Up to 6 servers can concurrently store sales prior to finalising them. Using this feature, sales can be progressed and advice given to customers without time pressure or queue build up at the till.

Safety at the point of sale

Today, many insurance policies require that owners do not keep more than a specified amount of cash in the ECR drawer. The **MND 999** displays a Cash Lift Alarm when this limit has been reached. The **MND 999** can also be set so that operation is impossible with the drawer open. An alarm can draw attention when the drawer is not closed within a pre-programmed period.

Security In your business

To obtain the level of security you want you can select from Compulsory Closed Drawer, Drawer Open Alarm, Compulsory Server ID, Management Control of Security Sensitive Operations, Compulsory Change Computation, Compulsory Cash Declaration and High Amount Lock Out. Secret Password Protection is available for Reports, Training Mode and Programming.
